



APS Team collaborates with counterparts in Guam

Guam, like many other states/territories with an APS program, received Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act of 2021 funding and was looking for ways to improve its services to clients. Guam has an emergency receiving home program where they provide emergency shelter to clients who



are in abusive situations and need to be relocated immediately. Guam APS wanted to expand the program and find a more efficient way to assist clients while connecting them with long-term resources. Georgia runs a Temporary Emergency Respite Fund (TERF) program, and thus, Georgia APS was connected to share about how the TERF program was developed, how it has expanded over the years and how it helps our clients.

The APS team met virtually with the team in Guam late in the evening on March 14, due to Guam being 14 hours ahead of Georgia, and discussed how Georgia's TERF program was developed and how we partner with different agencies to safely relocate clients.

The Guam APS team was pleased with the information presented and asked for a follow up meeting to ask more questions. Great job to the APS team who did an excellent job showcasing the work we are doing in Georgia.

Georgia Mountains Region APS advocate saves client's life

APS staff never know what kind of situations they are walking into, but APS advocate Sara Aycock got the surprise of a lifetime recently. She went to check on a new referral only to find herself in a life-or-death situation.

Sara received a referral for a client that was hospitalized the day before. She went to the client's house and as she arrived, a man ran out of the house saying, "He needs Narcan!" and that the client had gotten into something he shouldn't have. Sara called 911, went into the house and found the client unresponsive. The 911 operator stayed on the phone with her, and she performed CPR on the client until EMS arrived to administer Narcan and transport him to the hospital. It took a long time, but they were able to bring him back to life.

Sara was in the right place at the right time and was able to save the man's life. As her supervisor Emily Shook said, "I'm so proud to have Sara on my team. Her gut instinct told her to jump in and give CPR to someone in need, and she put herself at risk going into a home not knowing what she would find. She remained calm and followed the instructions from 911. She is not only an asset to our team, but to the state of Georgia."

Southern Georgia AAA recognized for farmers' market program

SGRC-AAA's Director Scott Courson recently announced that the AAA's Senior Farmers' Market Nutrition Program (SFMNP) was awarded a First Place Platinum Certificate of Achievement for FFY 2021 for serving the highest number of SFMNP participants in Georgia.

The SGRC-AAA issued and redeemed 2,703 vouchers during the 2021 market season, and as a result, the program served triple the number of participants as the previous year. The upcoming SFMNP program began in May 2022 and will continue through September. Each person aged 60 and older who qualifies for the program will receive \$30 worth of fresh fruits and vegetables from a SFMNP-approved farmer. A special shoutout goes to the AAA staff who administered the program -- Shawn Taylor, Linda Gail and Simone Popham.

Sowega Council on Aging Claris Companion Project makes difference in lives of seniors

The Sowega Council on Aging is proud of the results from utilizing the Claris Companion Project. The Claris Companion was founded in 2012 to provide seniors, family and care providers a platform to deliver high quality care at home. The goal of the project is to ensure that seniors are socially engaged and able to receive telehealth and remote rehabilitation easily.

25 seniors in Southwest Georgia had the opportunity to utilize the tablets to access wellness and evidence-based programs, at no cost to them, since June 2021. During the last month (April 5, 2022- May 4, 2022), 22 of the clients were active for a total of

1,970 interactions. They initiated 1,848 activities and had access to 1,069 websites and apps on their devices. The clients were able to stray away from boredom by playing 303 different games during the one-month period. Data shows that all 22 of the users completed exercise classes during the month.

Many of the users learned new skills and increased their creativity since receiving their device. Seniors who use the devices have been said to feel less isolated and more engaged. There has been an increase in physical activities, better health management and reduction in pain with many of the users. The Sowega Council on aging plans to distribute 37 additional tablets in June so that more seniors will continue living longer, living safer and living well from the comfort of their homes.

An At-Risk Adult Crime Tactics Specialist is a professional trained in recognizing and responding to the abuse, neglect and exploitation of vulnerable adults. An Adult Crime Tactics (ACT) Certified Specialist is knowledgeable in identifying at-risk adult abuse, understands the different types of abuse, the role of adult protective services and how to identify available resources. The ACT training is not open to the general public. Applicants must be first responders or in a field of work that requires mandated reporting of vulnerable adult abuse.
