The abuse, neglect, and exploitation of vulnerable adults is on the rise in Georgia. Take a look at exploitation, for example: Between 2007 and 2014, Georgia's banks and other financial institutions reported 300% more incidences of suspected financial exploitation to Adult Protective Services.

To address this increasing problem, the **DHS Division of Aging Services Forensic Special Initiatives Unit (FSIU)** partners with other state and federal agencies, as well as with the private sector, to increase awareness and provide professionals with specific training on at-risk adult abuse. <u>Click here</u> to learn more about the work that FSIU and its partners do to improve protections for vulnerable Georgians. Here's how you can take action:

1. Report suspected abuse, neglect, and exploitation.

Victimization can involve physical, emotional, sexual, and financial abuse; financial exploitation; neglect by others; and self-neglect. <u>Click here</u> for a list of warning signs. To report abuse in a home or other community setting, contact Georgia Adult Protective Services at 1-866-552-4464, option 3, or <u>visit this link for more information</u>.

To report abuse in a long-term care facility, contact the Georgia Department of Community Health Office of Healthcare Facility Regulation at 1-800-878-6442.

Always call 911 if a vulnerable adult is in immediate danger.

2. Host a presenter.

3. Distribute materials.
